DIRECTIONS: TOILET BOWLS & URINALS: Add one pod into a one-quart (32 oz.) trigger spray bottle. Add tap water up to the bottle's neck. Wait two minutes* and then shake vigorously. Spray directly into the toilet bowl or urinal or onto the bowl mop before swabbing.

GENERAL CLEANING: Follow the directions above, and then spray on the surface to be cleaned. Wipe off excess product with a clean, dry paper towel or lint-free cloth.

INSTRUCCIONES: INODOROS Y URINARIOS: Agregue una cápsula a una botella con atomizador de gatillo de un cuarto de galón (32 oz.). Agregue agua del grifo a la base del cuello de la botella. Espere dos minutos* y luego agite vigorosamente. Rocíe directamente en la taza del inodoro o urinario o en el trapeador de taza antes de limpiar.

LIMPIEZA GENERAL: Siga las instrucciones de arriba, y luego rociar sobre la superficie a limpiar. Retirar el exceso de producto con una toalla de papel limpio y seco o un paño sin pelusa.
